BRIEF OF EVIDENCE OF IRITEKURA MARIE DOBBS

Introduction

- 1. My name is Iritekura Marie Dobbs
- I was born in 1934.
- 3. I am a current trustee of the Harataunga Marae. I am also the treasurer.

Ngaropi's intentions for Harataunga 2C1

- 4. I am in no doubt that in the end Ngaropi agreed for this land to be used as a marae by the residents of Kennedy's Bay.
- 5. On this aspect, I have formerly submitted a personal statement to the Maori Land Court in respect of Harataunga 2C1. This was at the time when we were having serious troubles with our marae. That statement is attached herewith and marked "A". I will read it.
- 6. I would like to add the following statements to that letter:
 - 6.1. As I have mentioned, it recalls a conversation involving Ngaropi at our house. I believe that this conversation took place in the late 1960's;
 - 6.2. Ngaropi was frustrated with the lack of progress. In that same conversation, she made me and the others give our word that we would work towards getting a building up. We gave her our word;
 - 6.3. I believe that her main purpose for visiting Harataunga was to deal with her land interests there.
- 7. Our lawyer, Mr Kahukiwa, has shown me a copy of the applicants document number 5. It is a petition made in about 1962, and which was also sent to the Court. My mother is recorded as supporting the desire to establish a marae for the residents of Kennedy Bay.

- 8. Kennedy Bay, as a community catchment, has to my knowledge always included our Ngati Porou people of Tuateawa.
- 9. I have prepared a list of residents who are living in that community catchment today. It is attached marked "B".
- 10. I have endeavoured to indicate the status of the people who live at Kennedy Bay as either Ngati Porou or resident, meaning non-Ngati Porou. I have included their names and addresses.
- 11. Of the pakeha, or non-Ngati Porou who participate in our marae, by far the majority are those who have married in. Other pakeha now have a minimal participation. For instance, Paul Schubert's parents, who have since passed, were active in the 1960's, but he has not been.

Personal Statement by Iritekura Marie Dobbs

My name is Iritekura Marie Dobbs. I am the youngest daughter of Maku Hale and Riria, nee Harrison. Whakapapa on my mother's side is as follows:

> Ahinariki Tutaepa Mere Ngawaka Aporo Hikitapua Mereana Tauke Frank Harrison Riria Harrison = Maku Hale Marie Hale Harold Dobbs

My parents had a close association with Heni Ngaropi White which extended back and prior to 1922, because she named my fourth brother who was born in Waipiro Bay on 18,4.22. His name was Tawai Noa Takahi o te Rangi, who eventually became known as Tom. Mrs. White owned property in Harataunga including the block known as Harataunga 2C1 which she had gifted to the people of Kennedy Bay for the purpose of a marae.

On one of her occasional visits to Kennedy Bay when she usually stayed with my mother. Mrs. White made it clear to us (my husband Harold, Tom and myself) that she was disappointed at the lack of progress regarding the marae, and was contemplating giving Harataunga 2C1 to Tom.

Eventually, she agreed not to change the status of the land providing we assured her that we would do all we could towards getting a building on the land. There was no mention of Nga Hapu e Toru. Mrs. White stated that the marae would serve the people of Harataunga 'both pakeha and Maori". Fundraising became the priority! We were a totally united community focussed solely on building a marae. We were fortunate at the time (1970s) that we had a pakeha couple (Peter and Yvonne Hutchinson) who resided in Kennedy Bay who kept us motivated.

I am still closely involved with the marae today, being the Treasurer of both the Marae Trust and the Marae Committee.

In conclusion I would like to say how saddened I am that the request to change the status of the marae has created such discord among the families in Harataunga. The hundreds of people, many of whom are pakeha, like Helen Mason who gave \$10,000 towards the Wharenui fund, and who ran pottery making courses for the rangatahi of the marae to make vessels for use in the kauta. Many who have helped financially over the years will feel excluded because they do not whakapapa to Nga Hapu e Toru.
